This resolution directs the proper City officers to execute a Quit Claim Deed (QCD-2831), document conveying the sanitary and storm sewers located in vacated North 2<sup>nd</sup> Street between West Melvina Street and the Wisconsin Southern Railroad Company railroad right-of-way. The sewers are being conveyed because they are no longer needed for public use.

Whereas, In 1918, the City of Milwaukee constructed a 8-inch diameter sanitary sewer and a 12-inch diameter storm sewer in North 2<sup>nd</sup> Street; and

Whereas, At petitioner's request, North 2<sup>nd</sup> Street between West Melvina Street and the Wisconsin Southern Railroad Company railroad right-of-way was vacated on December 12, 2006, by Resolution No. 040327; and

Whereas, Due to the vacation of a portion of North 2<sup>nd</sup> Street on December 12, 2006, the sanitary and storm sewers located in the vacated area no longer serve the public interest; and

Whereas, The petitioner has agreed to accept ownership of said sanitary and storm sewers; now, therefore, be it
