THE CHAIR

Resolution directing the Department of City Development to prepare a resolution to vacate unimproved West James Street, West Kilbourn Avenue and North 48th Street in the area bounded by West Wells Street, North 49th Street, the Stadium Freeway and the Menomonee River, in the 10th Aldermanic District.

This resolution directs the Department of City Development to prepare a resolution to vacate said right-of-way in accordance with vacation proceedings under power granted to the City of Milwaukee by Section 62.73, Wisconsin Statutes, and Section 308-28, Milwaukee Code of Ordinances. This vacation was requested by the Milwaukee Department of Public Works, since said right-of-way is not needed for public purposes.

Whereas, It has been proposed by the Department of City Development that unimproved West James Street, West Kilbourn Avenue and North 48th Street in the area bounded by West Wells Street, North 49th Street, the Stadium Freeway and the Menomonee River be vacated pursuant to the provisions of Section 62.73, Wisconsin Statutes; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that the Department of City Development is directed to prepare a resolution to vacate said right-of-way in accordance with Section 308-28 of the Milwaukee Code of Ordinances.
