THE CHAIR

Substitute resolution determining it necessary to make various assessable public improvements at various locations and appropriating funds for these purposes with the City engineering cost estimated to be \$96,000 for a total estimated cost of these projects being \$1,828,000.

This resolution authorizes engineering studies and directs the Commissioner of Public Works to determine any benefits or damages which would result if the projects were to be constructed. After the Commissioner files his report, a Public Hearing will be held on those projects determined assessable. A resolution will be submitted after the Public Hearing authorizing construction. The City cost for engineering these projects is estimated to be \$96,000 with the total cost estimated to be \$1,828,000.

Resolved, By the Common Council of the City of Milwaukee that it is necessary and in the public interest to do the following described work according to City specifications, and that such public improvements and resulting special assessments be made pursuant to Section 66.0703 and any other pertinent sections of the Wisconsin Statutes and in the manner directed by Section 115-42 of the Milwaukee Code of Ordinances:

1st Aldermanic District

N. 28th St. - W. Atkinson Ave. to W. Glendale Ave. (ST211060103): Paving the roadway with concrete and widening. Laying a concrete curb and gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work. (Nonassessable Reconstruction Paving Fund -- \$6,000, Additional Funds). The total estimated cost for this project including the requested amount is \$280,000. This project is anticipated to be completed during the 2013 construction season.

Alley between W. Hampton Ave., N. Hopkins St., W. Stark St., and N. 39th St. (ST212140128): Paving the alley with concrete. Doing all the necessary grading pertaining to said work. (Nonassessable Alley Paving Fund -- \$9,000). The total estimated cost for this project including the requested amount is \$82,000. This project is anticipated to be completed during the 2014 construction season.

3rd Aldermanic District

N. Oakland Ave. - N. Cambridge Ave. to 480 feet m/l north of E. Windsor Pl. (Including N. Cambridge Ave. - E. Brady St. to N. Oakland Ave.) (ST211040106): Paving the roadway with concrete. Laying a concrete curb and gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work. (Nonassessable Reconstruction Paving Fund -- \$20,000, Additional Funds). The total estimated cost for this project including the requested amount is \$580,000. This project was constructed in 2012.

5th Aldermanic District

N. 97th St. - W. Keefe Ave. to W. Lisbon Ave. (ST211130101): Paving the roadway with asphalt. Laying a concrete curb and gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work. (Nonassessable Reconstruction Paving Fund -- \$8,000, Additional Funds). The total estimated cost for this project including the requested amount is \$158,000. This project is anticipated to be completed during the 2013 construction season.

7th Aldermanic District

W. Hope Ave. - N. 35th St. to N. 38th St. (ST211140146): Paving the roadway with asphalt. Laying a concrete curb and gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work. (Nonassessable Reconstruction Paving Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$128,000. This project is anticipated to be completed during the 2014 construction season.

10th Aldermanic District

W. Dana Ct. - A point west of N. 84th St. to N. 84th St. (ST211120153): Paving the roadway with asphalt. Laying a concrete curb and gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work. (Nonassessable Reconstruction Paving Fund -- \$6,000, Additional Funds). The total estimated cost for this project including the requested amount is \$70,000. This project is anticipated to be completed during the 2012 construction season.

W. Michigan St. - N. 91st St. to N. 93rd St. (including N. 93rd St. - W. Blue Mound Rd to W. Wisconsin Ave.) (ST211120131): Paving the roadway with asphalt. Laying a concrete curb and

gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work. (Nonassessable Reconstruction Paving Fund -- \$6,000, Additional Funds). The total estimated cost for this project including the requested amount is \$200,000. This project was constructed in 2012.

W. St. Paul Ave. - N. 91st St. to N. 92nd St. (including N. 91st St. - W. St. Paul Ave. to W. Blue Mound Rd.) (ST211120149): Paving the roadway with asphalt. Laying a concrete curb and gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work. (Nonassessable Reconstruction Paving Fund -- \$6,000, Additional Funds). The total estimated cost for this project including the requested amount is \$75,000. This project was constructed in 2012.

14th Aldermanic District

S. Lenox St. - E. Conway St. to E. Lincoln Ave. (ST211140145): Removing and replacing all curb and gutter. Removing and replacing concrete sidewalk and driveway approaches where necessary. Doing all the necessary grading pertaining to said work. (Nonassessable Reconstruction Paving Fund -- \$8,000). The total estimated cost for this project including the requested amount is \$55,000. This project is anticipated to be completed during the 2014 construction season.

E. Pryor Ave. - A point east of S. California St. to S. Kinnickinnic Ave. (ST21190238): Paving the roadway with asphalt. Laying a concrete curb and gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work. (Nonassessable Reconstruction Paving Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$200,000. This project is anticipated to be completed during the 2014 construction season.

; and, be it

Further Resolved, That the abutting and adjacent properties be assessed a portion of the cost, said assessment to be recommended by the Commissioner of Public Works in his report; and, be it

Further Resolved, That all assessments and payments be made in accordance with Section 115-42 of the Milwaukee Code of Ordinances; and, be it

Further Resolved, That all City departments are authorized to do engineering, surveying, preparing of plans, and estimates of cost thereof, to be utilized in the preparation of said report of the Commissioner of Public Works; and, be it

Further Resolved, That the Department of Public Works is authorized to use the funding as specified in the above description of work; and, be it

Further Resolved, That the City Comptroller is authorized and directed to transfer such funds which are available for this purpose to the appropriate capital Project/Grant accounts.
