THE CHAIR

Substitute resolution determining it necessary to make various nonassessable public improvements at various locations and appropriating funds for these purposes with the City engineering cost estimated to be \$291,000 for a total estimated cost of these projects being \$6,135,760.

This resolution authorizes engineering studies on projects which by City Charter are nonassessable. After design plans and estimates of costs have been prepared, a resolution authorizing construction will be submitted to the Common Council. The City cost for engineering these projects is estimated to be \$291,000 with the total cost estimated to be \$6,135,760.

Resolved, By the Common Council of the City of Milwaukee, that it is necessary and in the public interest to do the following described improvements according to City specifications:

Further Resolved, That the City Comptroller is hereby authorized to create within the Capital Improvement Fund, Grant and Aid Projects, the necessary Project/Grant Chartfield Values for preliminary engineering for the projects (Expenditure) and transfer to any of these accounts the amount required under grant agreement and City Accounting Policy but not to exceed a 10 percent increase of the total amounts reserved for the grantor's share and local share or \$5,000 whichever is

greater, as follows:

3rd Aldermanic District

N. Humboldt Blvd. - W. Clarke St. to W. Center St. (SM495130011): Combined sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$97,000. This project is anticipated to be completed during the 2013 construction season.

3rd and 6th Aldermanic Districts

N. Bremen St. - E. North Ave. to E. Meinecke Ave. (SM495130009): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$155,000. This project is anticipated to be completed during the 2013 construction season.

E. Meinecke Ave. - N. Fratney Ave. to N. Weil St. (SM495130010): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$169,000. This project is anticipated to be completed during the 2013 construction season.

4th Aldermanic District

N. 27th St. (STH 57) - W. St. Paul Ave. to W. Highland Blvd. (ST320060701) State Project I.D. (2265-09-00): Preliminary engineering for concrete pavement reconstruction, replace all curb and gutter, sidewalk and driveway approaches, sodding and grading.

W. Juneau Ave. - N. Old World Third St. to N. 5th St. (SM495130008): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$356,000. This project is anticipated to be completed during the 2013 construction season.

7th Aldermanic District

N. 38th St. - W. Burleigh St. to W. Fond du Lac Ave. (SM495130012): Sanitary sewer relay. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$158,000. This project is anticipated to be completed during the 2013 construction season.

10th Aldermanic District

- N. 55th St. W. McKinley Ave. to W. Vliet St. (SM495130003): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$216,000. This project is anticipated to be completed during the 2013 construction season.
- N. 59th St. W. Center St. to W. Appleton Ave. (US-41) (SM495130007): Relaying sanitary sewer and storm sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$94,000. This project is anticipated to be completed during the 2013 construction season.
- W. Appleton Ave. (US-41) W. Center St. to N. 59th St. (SM495130004): Relaying sanitary sewer and storm sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$122,000. This project is anticipated to be completed during the 2013 construction season.
- W. Lisbon Ave. N. 60th St. to W. Avondale Bl. (SM495130002): Sanitary sewer relay. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$280,000. This project is anticipated to be completed during the 2013 construction season.

S. Water St. - 170 feet m/l north of E. Florida St. to E. Florida St. (SM495130006): Combined large diameter sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$10,000). The total estimated cost for this project including the requested amount is \$58,000. This project is anticipated to be completed during the 2013 construction season.

14th Aldermanic District

S. 6th St. - W. Manitoba St. to W. Euclid Ave. (SM495130005): Sanitary and combined sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$353,000. This project is anticipated to be completed during the 2013 construction season.

Alterations by Milwaukee Water Works Distribution Prior to Paving (WT410130730): Alterations. (Nonassessable Water Fund Budget Line 6410 -- \$15,000). The total estimated cost for this project including the requested amount is \$50,000. This project is anticipated to be completed during the 2013 construction season.

Water Main Alterations by Private Contractor Prior to Paving (WT410130750): Water main alterations. (Nonassessable Water Fund Budget Line 5010 -- \$7,000; Nonassessable Water Fund Budget Line 6410 -- \$8,000). The total estimated cost for this project including the requested amount is \$100,000. This project is anticipated to be completed during the 2013 construction season.

Water Main Alterations by Private Contractor Prior to Sewer Construction (WT410130770): Water main alterations. (Nonassessable Water Fund Budget Line 5010 -- \$4,000; Nonassessable Water Fund Budget Line 6410 -- \$5,000). The total estimated cost for this project including the requested amount is \$50,000. This project is anticipated to be completed during the 2013 construction season.

Post Guarantee Inspections on Water Main Projects (WT440130850): Restoration inspection of water main projects. (Nonassessable Water Fund Budget Line 5010 -- \$5,000). The total estimated cost for this project including the requested amount is \$5,000. This project is anticipated to be completed during the 2013 construction season.

Water Main Material Inspection (WT410130880): Material inspection. (Nonassessable Water Fund Budget Line 6410 -- \$15,000). The total estimated cost for this project including the requested amount is \$15,000. This project is anticipated to be completed during the 2013 construction season.

Various Suburbs

Review of Consultant Prepared Suburban Construction Plans (WT440130800): Plan review. (Nonassessable Water Fund Budget Line 5010 -- \$30,000; Nonassessable Water Fund Budget Line 6410 -- \$20,000). The total estimated cost for this project including the requested amount is \$50,000. This project is anticipated to be completed during the 2013 construction season.
