Resolution approving construction of nonassessable public improvements at various locations and appropriating funds for these purposes with the City construction cost estimated to be \$396,000 for a total estimated cost of these projects being \$460,000.

This resolution directs the installation and construction of certain public improvements which have been determined to be nonassessable by the Commissioner of Public Works. The City cost of the projects approved by this resolution is estimated to be \$396,000. The total estimated cost of these projects is \$460,000.

Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions determining it necessary and in the public interest to construct nonassessable improvements; and

Whereas, Plans, specifications and cost estimates have been prepared for the following described improvements:

7th Aldermanic District

N. 40th St. - W. Fiebrantz Ave. to W. Hope Ave. (SM495120013) File Number 111282: Sanitary

sewer relay. (Nonassessable Sewer Maintenance Relay Fund -- \$155,000). The total estimated cost for this project including the requested amount is \$170,000. This project is anticipated to be completed during the 2013 construction season.

#### 12th Aldermanic District

S. 16th St. - W. Arthur Ave. to the Kinnickinnic River (SM495120137) File Number 121215: Sanitary and storm sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$80,000). The total estimated cost for this project including the requested amount is \$90,000. This project is anticipated to be completed during the 2013 construction season.

#### Various Aldermanic Districts

Alterations by Milwaukee Water Works Distribution Prior to Paving (WT410130730) File Number 121332: Alterations. (Nonassessable Water Fund Budget Line 6410 -- \$35,000). The total estimated cost for this project including the requested amount is \$50,000. This project is anticipated to be completed during the 2013 construction season.

Water Main Alterations by Private Contractor Prior to Paving (WT410130750) File Number 121332: Alterations. (Nonassessable Water Fund Budget Line 6410 -- \$85,000). The total estimated cost for this project including the requested amount is \$100,000. This project is anticipated to be completed during the 2013 construction season.

Water Main Alterations by Private Contractor Prior to Sewer Construction (WT410130770) File Number 121332: Water main alterations. (Nonassessable Water Fund Budget Line 6410 -- \$41,000). The total estimated cost for this project including the requested amount is \$50,000. This project is anticipated to be completed during the 2013 construction season.
