Resolution approving a final Certified Survey Map for property located at 339 West Pittsburgh Avenue to subdivide the existing Reed Street Yards parcel and to dedicate land for public street purposes, in the 12th Aldermanic District.

This resolution approves a final Certified Survey Map that subdivides the Reed Street Yards into three lots, one out-lot, and dedicates land for the proposed Freshwater Way public right-of-way.
