Substitute resolution relating to the termination of historic designation for 1131 N. 13th Street, former William Sieglaff Duplex, in the 4th Aldermanic District.

This resolution terminates permanent historic designation to the former William Sieglaff Duplex, located at 1131 N. 13th Street.

Whereas, The Milwaukee Historic Preservation Ordinance, s. 320-21-17 of the Code of Ordinances, provides that historic structures not located in a historic district and damaged beyond repair may be terminated of historic designation by the Common Council upon the recommendation of the Historic Preservation Commission and report from the Commissioner of Neighborhood Services; and

Whereas, The Historic Preservation Commission at its March 11, 2013 meeting, by a vote of five (5) ayes, zero (0) noes, and two (2) excused, recommended to terminate the historic designation of the former William Sieglaff Duplex located at 1131 N. 13th Street; and

Whereas, This structure has been determined damaged beyond repair by the Historic Preservation

Resolved, By the Common Council of the City of Milwaukee, that the former William Sieglaff Duplex, located at 1131 N. 13th Street, and further described as follows:
