Substitute resolution relating to the termination of historic designation for 2863 N. 1st Street, former Daniel Richards House, in the 6th Aldermanic District.

This resolution terminates permanent historic designation to the former Daniel Richards House, located at 2863 N. 1st Street.

Whereas, The Milwaukee Historic Preservation Ordinance, s. 320-21-17 of the Code of Ordinances, provides that historic structures not located in a historic district and damaged beyond repair may be terminated of historic designation by the Common Council upon the recommendation of the Historic Preservation Commission and report from the Commissioner of Neighborhood Services; and

Whereas, The Historic Preservation Commission at its March 11, 2013 meeting, by a vote of five (5) ayes, zero

Resolved, By the Common Council of the City of Milwaukee, that the former Daniel Richards House, located at 2863 N. 1st Street, and further described as follows:

Tax Key No: 3131354000, RICHARDS ADDITION,(S A) IN NE 1/4 SEC 17-7-22 BLOCK 5 W 70' (LOTS 21 & 22)

is terminated as a Milwaukee historic structure.
