## THE CHAIR

Substitute resolution approving construction of nonassessable public improvements at various locations and appropriating funds for these purposes with the City construction cost estimated to be \$529,000 for a total estimated cost of these projects being \$581,000.

This resolution directs the installation and construction of certain public improvements which have been determined to be nonassessable by the Commissioner of Public Works. The City cost of the projects approved by this resolution is estimated to be \$529,000. The total estimated cost of these projects is \$581,000.

Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions determining it necessary and in the public interest to construct nonassessable improvements; and

Whereas, Plans, specifications and cost estimates have been prepared for the following described improvements:

### 1st Aldermanic District

N. Green Bay Ave. at W. Hampton Ave. (ST211130175) File Number 121213: Laying concrete walk and concrete curb and gutter. Doing all necessary grading pertaining to said work. (Nonassessable Reconstruction Paving Fund -- \$45,000). The total estimated cost for this project including the requested amount is \$50,000. This project is anticipated to be completed during the 2013 construction season.

W. Hope Ave. - N. 19th St. to N. 19th Pl. (SM495120081) File Number 120702: Relay sanitary sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$63,000). The total estimated cost for this project including the requested amount is \$75,000. This project is anticipated to be completed during the 2013 construction season.

#### 1st and 7th Aldermanic Districts

N. 40th St. - W. Courtland Ave. to W. Hampton Ave. (SM495110057) File Number 111474: Relay sanitary sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$124,000). The total estimated cost for this project including the requested amount is \$139,000. This project is anticipated to be completed during the 2013 construction season.

#### 7th Aldermanic District

N. 40th St. - W. Vienna Ave. to W. Roosevelt Dr. (SM495110074) File Number 111474: Relay sanitary sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$102,000). The total estimated cost for this project including the requested amount is \$117,000. This project is anticipated to be completed during the 2013 construction season.

#### 12th Aldermanic District

E. Greenfield Ave. - C. & N.W. Railway Right-of-Way to the Kinnickinnic River (SM493130103) File Number 121678: Best Management Practices (BMPs) for storm water quality. (Nonassessable TSS Removal Fund -- \$195,000). The total estimated cost for this project including the requested amount is \$200,000. This project is anticipated to be completed during the 2013 construction season.
