### ALD. DONOVAN

A substitute ordinance relating to the change in zoning from Industrial-Heavy to Parks, for a park, on land located along the south bank of the Menomonee River between South 25<sup>th</sup> Street extended on the east and South 39<sup>th</sup> Street extended on the west, in the 8th Aldermanic District.

This zoning change was requested by the Redevelopment Authority of the City of Milwaukee and will permit development of a park at the former Menomonee Valley Airline Yards site. Resolved, That the Mayor and Common Council of the City of Milwaukee, do ordain as follows:

Part 1. There is added to the Milwaukee Code of Ordinances a new section to read as follows:

Section 295-901.0005. The zoning map is amended to change the zoning for part of 610 South 35th Street, Tax Key No. 424-0403-000, which includes proposed Lots 2 and 3 of CSM DCD No. 2951, legal descriptions as follows:

That part of Parcel 3 of Certified Survey Map No. 7701, recorded on January 20, 2006 as Document No. 9169724, being Parcel 2 of Certified Survey Map No. 2655 and lands in the Northeast 1/4, Northwest 1/4, Southwest 1/4 and Southeast 1/4 of the Northeast 1/4 of Section 36, the Southeast 1/4 and Southwest 1/4 of the Northwest 1/4 of Section 36, Town 7 North, Range 21 East, and the Northwest 1/4 and Southwest 1/4 of the Northwest 1/4 of Section 31, Town 7 North, Range 22 East, in the City of Milwaukee, Milwaukee County, Wisconsin, bounded and described as follows:

Commencing at the Northwest corner of said Northeast 1/4 of Section 36; thence South 01° 37'12" East along the west line of said Northeast 1/4 Section 1335.48 feet to the southerly line of West Canal Street and to the point of beginning; thence North 49°27'55" East, 57.42 feet along said southerly line to the North corner of aforesaid Parcel 3; thence South 01°40'35" East, 815.38 feet along the east line of Lot 1 and Lot 2 of Certified Survey Map No. 8252; thence the following four courses along the south line of said Lot 1 and Lot 2 of Certified Survey Map No. 8252; thence North 56°05'48" East, 148.36 feet; thence North 72°26'45" East, 68.31 feet; thence North 65°37'43" East, 259.28 feet; thence North 67°30'26" East, 264.08 feet to the Southeast corner of said Lot 1; thence South 01°31'48" East, 143.25 feet along a Southerly extension of the westerly line of South 33rd Court; thence the following two courses along the approximate centerline of the Menomonee River; thence South 69°08'16" West, 634.34 feet; thence South 50°51'56" West, 155.61 feet to the west line of said Northeast 1/4 Section; thence South 01°37'12" East along said west line 286.78 feet to the northerly line of the Soo Line Railroad; thence South 84°17'11" West, 1020.98 feet along said northerly line to the beginning of a 6053.57 foot radius curve to the right, whose chord bears South 85°26'00" West, 242.34 feet; thence Southwesterly, 242.36 feet along the arc of said curve; thence North 01° 42'25" West, 179.20 feet to the southerly line of West Canal Street; thence the following seven courses along the southerly and easterly lines of said West Canal Street; thence North 83°01'39" East, 24.43 feet; thence North 87°11'49" East, 377.57 feet to a curve whose center lies to the Northwest, having a radius of 672.00 feet, and whose chord bears North 45°15'13" East, 898.33 feet; thence Northeasterly along the arc of said curve 983.89 feet; thence North 03°18'36" East, 172.51 feet to the beginning of a curve whose center lies to the Southeast, having a radius of 433.00 feet, and whose chord bears North 20°01'40" East, 249.11 feet; thence Northeasterly along the arc of said curve 252.68 feet; thence North 36°44'44" East, 75.51 feet; thence North 49°27'55" East, 63.90 feet to the point of beginning.
