THE CHAIR

A substitute ordinance relating to traffic controls.

This ordinance establishes the above-mentioned traffic requirements in various parts of the City.

The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 101-12-4-a of the Code relating to Turn Lanes is amended by adding the following:

North Humboldt Avenue at East North Avenue right lane must turn right northbound

Part 2. Section 101-16-1 of the Code relating to Stop signs is amended by adding the following:

On West Edgerton Avenue and South 6th Street in all directions

On South Nevada Street and East Norwich Street in all directions

Part 3. Section 101-16-2 of the Code relating to Through Highways is amended by striking the following:

"West McKinley Avenue from west line of North Hawley Road to North 60th Street"

"South 6th Street from 6th Street Viaduct ramp to north line of West College Avenue"

"North 60th Street from the north line of West McKinley Avenue to the south line of West Good Hope Road"

Part 4. Section 101-16-2 of the Code relating to Through Highways is amended by adding the following:

South 6th Street from West Canal Street to north line of West Edgerton Avenue

South 6th Street from south line of West Edgerton Avenue to West College Avenue

North 60th Street from the north line of West Vliet Street to the south line of West Good Hope Road
