THE CHAIR

Substitute resolution approving levying of assessments and construction of assessable public improvement projects at various locations and appropriating funds for these purposes with the City cost of these projects approved by this resolution is estimated to be \$1,014,700 for a total estimated cost of \$1,101,000.

This resolution confirms the report of the Commissioner of Public Works, as modified by the Common Council Committee, on projects for which Public Hearings have been held. The resolution authorizes the levying of special assessments and directs the installation and construction of said public improvements. The City cost of these projects approved by this resolution is estimated to be \$1,014,700. The total estimated cost of these projects is \$1,101,000.

Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions, determining it necessary and in the public interest to construct and levy special assessments for the following improvements:

N. Edison St. - E. State St. to E. Juneau Ave. (ST211110152) File Number 121550: Asphalt pavement resurfacing, replace all curb and gutter, replace all driveway approaches and replace sidewalk where necessary, sodding (5 - 8 foot width of tree border area), and grading. Also included, are permeable sidewalk and special drainage facilities. (Assessable Reconstruction Paving Fund -- \$22,700; TID34 (TD03484050) Nonassessable Paving Fund -- \$200,000). The total estimated cost for this project including the requested amount is \$245,000. This project is anticipated to be completed during the 2013-2014 construction season.

5th Aldermanic District

Alley between W. Center St., W. Lorraine Pl., N. 82nd St., and N. 84th St. (ST212060104) File Number 040945: Concrete alley pavement reconstruction, replace some abutting walk or driveway approaches, grading, and storm drainage facilities where necessary. (Assessable Alley Paving Fund -- \$23,000; Nonassessable Alley Paving Fund -- \$55,000). The total estimated cost for this project including the requested amount is \$85,000. This project is anticipated to be completed during the 2013-2014 construction season.

N. 9th St. - W. Burleigh St. to W. Keefe Ave. (ST211130166): Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund -- \$20,500; Nonassessable Reconstruction Paving Fund -- \$20,000). The total estimated cost for this project including the requested amount is \$41,000. This project is anticipated to be completed during the 2013-2014 construction season.

8th Aldermanic District

S. 22nd St. - W. Greenfield Ave. to W. Scott St. (ST211130179): Install traffic calming speed hump (s). (Assessable Reconstruction Paving Fund -- \$7,000; Nonassessable Reconstruction Paving Fund -- \$3,000). The total estimated cost for this project including the requested amount is \$10,000. This project is anticipated to be completed during the 2013-2014 construction season.

Alley between W. Branting Ln., W. Greenfield Ave., S. 35th St., and S. 36th St. (Southerly east-west leg and southerly half of north-south leg) (ST212130113) File Number 130232: Concrete alley pavement reconstruction, replace some abutting walk or driveway approaches, grading, and storm drainage facilities where necessary. (Assessable Alley Paving Fund -- \$10,100; Nonassessable Alley Paving Fund -- \$30,000). The total estimated cost for this project including the requested amount is \$41,000. This project is anticipated to be completed during the 2013-2014 construction season.

Alley between W. Crawford Ave., W. Howard Ave., S. 52nd St., and S. 53rd St. (ST212130110) File Number 130144: Concrete alley pavement reconstruction, replace some abutting walk or driveway approaches, grading, and storm drainage facilities where necessary. (Assessable Alley Paving Fund -- \$21,700; Nonassessable Alley Paving Fund -- \$40,000). The total estimated cost for this project including the requested amount is \$75,000. This project is anticipated to be completed during the 2013-2014 construction season.

Washington St. (ST211060117) File Number 121550: Concrete pavement reconstruction, replace all curb and gutter, replace sidewalk and driveway approaches, as necessary, sodding (6-7 foot width of tree border area), grading, and tree removal where necessary. (Assessable Reconstruction Paving Fund -- \$10,200; Nonassessable Reconstruction Paving Fund -- \$263,000). The total estimated cost for this project including the requested amount is \$286,000. This project is anticipated to be completed during the 2013-2014 construction season.

- S. 17th St. W. Euclid Ave. to W. Oklahoma Ave. (ST211130129) File Number 110922: Pavement reconstruction, replace all curb and gutter, replace sidewalk and driveway approaches where necessary, sodding (6-foot width of tree border area), grading, and tree removal where necessary. (Assessable Reconstruction Paving Fund -- \$8,500; Nonassessable Reconstruction Paving Fund -- \$110,000). The total estimated cost for this project including the requested amount is \$130,000. This project is anticipated to be completed during the 2013-2014 construction season.
- S. 19th St. W. Euclid Ave. to W. Oklahoma Ave. (ST211050103) File Number 091545: Pavement reconstruction, replace all curb and gutter, replace sidewalk and driveway approaches where necessary, sodding (7-foot width of tree border area), grading, and tree removal where necessary. (Assessable Reconstruction Paving Fund -- \$13,500; Nonassessable Reconstruction Paving Fund -- \$120,000). The total estimated cost for this project including the requested amount is \$150,000. This project is anticipated to be completed during the 2013-2014 construction season.

- S. Mound St. E. Lincoln Ave. to E. Bay St. (ST211130195): Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund -- \$8,300; Nonassessable Reconstruction Paving Fund -- \$10,000). The total estimated cost for this project including the requested amount is \$19,000. This project is anticipated to be completed during the 2013-2014 construction season.
- S. 5th Pl. W. Arthur Ave. to W. Hayes Ave. (ST211130190): Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund -- \$9,200; Nonassessable Reconstruction Paving Fund -- \$9,000). The total estimated cost for this project including the requested amount is \$19,000. This project is anticipated to be completed during the 2013-2014 construction season.

Further Resolved, That the Department of Public Works is authorized to use the funding as specified in the above description of work; and, be it

Center St. ST212060104), N. 9th St. (ST211130166), S. 22nd St. (ST211130179), S. 10th St. (ST211060117), S. 17th St. (ST211130129), S. 19th St. (ST211050103), S. Mound St. (ST211130195) and S. 5th Pl. (ST211130190) will be billed after January 1, 2015, but not before 12 months after the project contract has been completed; and, be it
