("L&R") owns the property at 4747 South Howell Avenue ("Property") and proposes to develop the Property with a mix of parking, hotel, retail and restaurant uses; and

Whereas, The City of Milwaukee ("City") wishes to see development of 4747 South Howell Avenue that is consistent with the Southeast Side Area Comprehensive Plan that was approved by Common Council File No. 080641 on October 29, 2008; and

Whereas, To further the goals of each party for the future development of the Property, the City and L&R wish to enter into a Development Agreement with terms substantially in accordance with the Term Sheet, a copy of which is attached to this Common Council File; now, therefore, be it
