- Analysis -

This resolution designates Villa Uhrig as an Historic Structure.

Whereas, The Milwaukee Historic Preservation Ordinance, Section 308-81 of the Milwaukee Code, provides that Historic Sites, Structures and Districts may be designated by the Common Council upon the recommendation of the Historic Preservation Commission; and

Whereas, The Historic Preservation Commission has adopted procedures for the purpose of making these recommendations; and

Whereas, The Historic Preservation Commission recommends that Villa Uhrig be designated as an Historic Structure; and

Whereas, This structure possesses integrity of location, design, setting, materials, workmanship and association and fulfills the following criteria set forth in Section 308-81(2)(e):

- e-1. Its exemplification of the development of the cultural, economic, social or historic heritage of the City of Milwaukee, State of Wisconsin or of the United States.
- e-5. Its embodiment of the distinguishing characteristics of an architectural type or specimen.

; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee that Villa Uhrig which is further described as follows:
