### 130599 Substitute 1 THE CHAIR

Substitute resolution determining it necessary to make various nonassessable public improvements at various locations and appropriating funds for these purposes with the City engineering cost estimated to be \$1,778,000 for a total estimated cost of these projects being \$11,817,000.

This resolution authorizes engineering studies on projects which by City Charter are nonassessable. After design plans and estimates of costs have been prepared, a resolution authorizing construction will be submitted to the Common Council. The City cost for engineering these projects is estimated to be \$1,778,000 with the total cost estimated to be \$11,817,000.

Resolved, By the Common Council of the City of Milwaukee, that it is necessary and in the public interest to do the following described improvements according to City specifications:

### 1st Aldermanic District

W. Hampton Ave. - N. Green Bay Ave. to N. 20th St. (SM495130064): Sanitary relocation. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$127,000. This project is anticipated to be completed during the 2014 construction season.

W. Hampton Ave. (north side) - N. 23rd St. to N. 24th Pl. (SM495130059): Storm sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$44,000. This project is anticipated to be completed during the 2014 construction season.

N. 24th Pl. - 180 feet m/l south of W. Hampton Ave. to 315 feet m/l north of W. Hampton Ave. (SM495130057): Sanitary sewer lining and storm sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$74,000. This project is anticipated to be completed during the 2014 construction season.

N. 24th St. - W. Purdue St. to W. Hampton Ave. (SM495130058): Storm sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$38,000. This project is anticipated to be completed during the 2014 construction season.

N. 27th St. - 110 feet m/l south of W. Stark St. to W. Lancaster Ave. (SM495130076): Relaying sanitary sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$266,000. This project is anticipated to be completed during the 2014 construction season.

#### 2nd Aldermanic District

N. 76th St. - W. Grantosa Dr. to W. Florist Ave. (WT410140009): Hydrant alteration. (Nonassessable Water Fund Budget Line 5010 -- \$3,000; Nonassessable Water Fund Budget Line 6410 -- \$12,000). The total estimated cost for this project including the requested amount is \$90,000. This project is anticipated to be completed during the 2014 construction season.

#### 3rd Aldermanic District

N. Bremen St. - E. Center St. to E. Hadley St. (SM495130054): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$144,000. This project is anticipated to be completed during the 2014 construction season.

#### 3rd and 4th Aldermanic Districts

E. Royall Pl. - N. Farwell Ave. to N. Prospect Ave. (SM495130075): Combined sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$75,000. This project is anticipated to be completed during the 2014 construction season.

#### 4th Aldermanic District

N. Cass St. - E. Mason St. to E. Wells St. (SM495130052): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$97,000. This project is anticipated to be completed during the 2013 construction season.

E. Erie St. at E. Menomonee St. (ST211140150): Intersection modification. (Nonassessable Reconstruction Paving Fund -- \$8,000). The total estimated cost for this project including the requested amount is \$25,000. This project is anticipated to be completed during the 2014 construction season.

N. 4th St. - W. Kilbourn Ave. to W. State St. (WT410140686): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$7,000; Nonassessable Water Fund Budget Line 6410 -- \$8,000). The total estimated cost for this project including the requested amount is \$150,000. This project is anticipated to be completed during the 2014 construction season.

N. 18th St. - W. Wells St. to W. State St. (SM495120128): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$244,000. This project is anticipated to be completed during the 2014 construction season.

#### 5th Aldermanic District

N. 100th St. - W. Grantosa Dr. to a point north of W. Congress St. (Sponsored by the City of Wauwatosa) (ST211130204): Paving the roadway with concrete. Laying a concrete curb and gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work. (Nonassessable Reconstruction Paving Fund -- \$10,000). The total estimated cost for this project including the requested amount is \$250,000. This project is anticipated to be completed during the 2013 construction season.

#### 6th Aldermanic District

Port Washington Ave. Bridge (4000 North) over Capitol Dr. (BR100130105): Preliminary engineering for bridge replacement. (City Share Non-assessable Structure Fund -- \$425,000). The total estimated cost for this project including the requested amount is \$3,425,000. This project is anticipated to be completed during the 2016 construction season.

W. Randolph St. - N. 4th St. to N. 5th St. (SM495130055): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$54,000. This project is anticipated to be completed during the 2014 construction season.

N. Richards St. - E. Meinecke Ave. to E. Center St. (SM495130074): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$427,000. This project is anticipated to be completed during the 2014 construction season.

N. 4th St. - W. Concordia Ave. to W. Keefe Ave. (SM495130056): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$248,000. This project is anticipated to be completed

during the 2014 construction season.

#### 7th Aldermanic District

W. Glendale Ave. - N. 44th St. to N. 45th St. (SM495130067): Sanitary Sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$32,000. This project is anticipated to be completed during the 2014 construction season.

N. 32nd St. - W. Auer Ave. to 550 feet m/l north of W. Auer Ave. (SM495130050): Installing new storm sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$173,000. This project is anticipated to be completed during the 2013 construction season.

N. 33rd St. - W. Auer Ave. to 550 feet m/l north of W. Auer Ave. (SM495130051): Installing new storm sewer and relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$139,000. This project is anticipated to be completed during the 2013 construction season.

#### 8th Aldermanic District

S. 34th St. - W. Rogers St. to W. Becher St. (SM495130066): Storm sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$92,000. This project is anticipated to be completed during the 2014 construction season.

S. 35th St. - W. Greenfield Ave. to W. Burnham St. (WT410140008): Hydrant alteration. (Nonassessable Water Fund Budget Line 5010 -- \$3,000; Nonassessable Water Fund Budget Line 6410 -- \$12,000). The total estimated cost for this project including the requested amount is \$30,000. This project is anticipated to be completed during the 2014 construction season.

#### 10th Aldermanic District

W. Monarch Pl. - 230 feet m/l east of N. 43rd St. to 130 feet m/l west of N. 45th St. (SM495130072): Sanitary sewer relay and lining. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$113,000. This project is anticipated to be completed during the 2014 construction season.

W. Wisconsin Ave. - N. 45th St. to N. 46th St. (SM495130065): Sanitary Sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$95,000. This project is anticipated to be completed during the 2014 construction season.

S. 62nd St. - W. Dixon St. to W. Adler St. (SM495130071): Relaying sanitary sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$143,000. This project is anticipated to be completed during the 2014 construction season.

#### 12th Aldermanic District

W. Hayes Ave. - S. 33rd St. to S. 35th St. (WT410140687): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$7,000; Nonassessable Water Fund Budget Line 6410 -- \$8,000). The total estimated cost for this project including the requested amount is \$130,000. This project is anticipated to be completed during the 2014 construction season.

W. Scott St. - S. 10th St. to S. 15th St. (SM495130068): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$633,000. This project is anticipated to be completed during the 2014 construction season.

S. Water St. - E. Bruce St. to E. Pierce St. (Ext'd) (SM495130069): Combined sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$64,000. This project is anticipated to be completed during the 2014 construction season.

S. 3rd St. - W. Lapham Blvd. to W. Orchard St. (SM495130063): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$142,000. This project is anticipated to be completed during the 2014 construction season.

#### 12th and 14th Aldermanic Districts

Becher St. Bridge (300 West) over the Kinnickinnic River (BR100130106): Preliminary engineering for bridge rehabilitation. (City Share Non-assessable Structure Fund -- \$275,000). The total estimated cost for this project including the requested amount is \$2,275,000. This project is anticipated to be completed during the 2016 construction season.

#### 13th Aldermanic District

W. Grange Ave. - 400 feet m/l west of S. Howell Ave. to S. Howell Ave. (SM495130053): Sanitary relocation. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$95,000. This project is anticipated to be completed during the 2013 construction season.

S. Howell Ave. - E. Layton Ave. to E. Howard Ave. (SM495130073): Sanitary sewer relay and lining. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$713,000. This project is anticipated to be completed during the 2014 construction season.

S. 6th St. Corridor permeable pavement demonstration project (ST211130202): Laying concrete walk and driveway. Doing all necessary grading pertaining to said work. (Nonassessable Reconstruction Paving Fund -- \$10,000). The total estimated cost for this project including the requested amount is \$25,000. This project is anticipated to be completed during the 2013 construction season.

#### 14th Aldermanic District

S. 4th St. - W. Becher St. to W. Lincoln Ave. (SM495130070): Combined large diameter sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this

project including the requested amount is \$293,000. This project is anticipated to be completed during the 2014 construction season.

#### 15th Aldermanic District

W. Lisbon Ave. - N. 30th St. to 130 feet m/l east of N. 31st St. (SM495130060): Combined large diameter sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$127,000. This project is anticipated to be completed during the 2013 construction season.

#### City Wide

2013 Maintenance Sewer Exams as requested (SM495130061): (Nonassessable Sewer Maintenance Relay Fund -- \$200,000). The total estimated cost for this project is \$200,000. This project is anticipated to be completed during the 2013 construction season.

2013 Maintenance Sewer Work (SM495130062): (Nonassessable Sewer Maintenance Relay Fund - \$200,000). The total estimated cost for this project is \$200,000. This project is anticipated to be completed during the 2013 construction season.

#### Various Aldermanic Districts

Asphalt surface overlay (ST211130205): (Nonassessable Reconstruction Paving Fund -- \$250,000). The total estimated cost for this project is \$250,000. This project is anticipated to be completed during the 2013-2014 construction season.

#### City of Glendale

N. Port Washington Rd. - W. Olive St. to W. Hampton Ave. (SM494130204): Manhole adjustments. (Nonassessable Sewer Maintenance Relay Fund -- \$1,000). The total estimated cost for this project including the requested amount is \$75,000. This project is anticipated to be completed during the 2013 construction season.
