Resolution authorizing the Commissioner of Public Works to execute an amended project agreement titled "Amended Cost Sharing Agreement Between the City of Milwaukee and the Village of Menomonee Falls" for the cost sharing of the preliminary engineering and construction of North 124th Street between West Brown Deer Road and West County Line Road with a revised total estimated cost of \$1,200,000, of which the City's share is \$600,000 and Menomonee Falls share is \$600,000. Resolution authorizing the Commissioner of Public Works to execute a project agreement titled "Amended Cost Sharing Agreement Between the City of Milwaukee and the Village of Menomonee Falls" for the cost sharing of the preliminary engineering and construction of North 124th Street between West Brown Deer Road and West County Line Road with a total estimated cost of \$1,200,000, of which the City's share is \$600,000 and Menomonee Falls share is \$600,000. Whereas, North 124th Street was constructed in prior to 1956 and is in need of rehabilitation; and

Whereas, Bids for the improvement were received in July 2013, and were higher than anticipated;

Whereas, The Cost Sharing Agreement, approved in October 2012, Resolution 120984 needs to be revised; and

Whereas, The project is included in the Department of Public Works Local Road Program; and

Whereas, The City of Milwaukee and the Village of Menomonee Falls share jurisdictional ownership of the roadway and will share the preliminary engineering and construction costs at a 50/50 share; and

Whereas, The City of Milwaukee will be the lead agency of the project design and construction; and

Whereas, The Village of Menomonee Falls Common Council is expected to adopt legislation authorizing signing of the proposed Amended Cost Sharing Agreement with the City of Milwaukee and funding their share of the project; and

Whereas, The Department of Public Works shall notify the Common Council of the City of Milwaukee of any such cost overruns and/or changes in scope approved by the Department of Public Works; and

Whereas, This project is programmed for construction in 2013; and

Whereas, Funding for the construction phase of the project was included in Resolution 130145; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that the Commissioner of Public Works is hereby authorized to execute the amended project agreement titled "Amended Cost Sharing Agreement Between the City of Milwaukee and the City of Menomonee Falls" for the cost sharing of the preliminary engineering and construction for the rehabilitation of the North 124th Street between West Brown Deer Road and West County Line Road, copies of which are attached to Common Council Resolution File Number 130602, and are incorporated by reference as though set forth in full; and, be it

Further Resolved, That the Commissioner of Public Works is hereby authorized to undertake engineering and construction for the rehabilitation of the roadway and to bill the Village of Menomonee Falls for engineering and construction costs incurred for the improvement.
