THE CHAIR

Ordinance relating to the change in zoning from Warehousing and Light Manufacturing (C9H) to Civic Activity (C9D-Subdistrict A), on land located on the South side of West Juneau Avenue and East of North 6th Street, in the 4th Aldermanic District. (DCD)

- Analysis -

This ordinance will permit civic or institutional type uses, offices and hotels, rather than manufacturing as currently permitted.
The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. There is added to the Milwaukee Code of Ordinances a new section to read as follows:

Section 295-441.0001. The zoning map is amended to change the zoning for the area bounded by the centerline of West Juneau Avenue, a line 50 feet West and parallel to the West line of North 5th Street; a line 100 feet South of the South line of West Juneau Avenue; the centerline of North 5th Street; the centerline of West Highland Avenue and the centerline of North 6th Street, from Warehousing and Light Manufacturing (C9H) to Civic Activity (C9D-Subdistrict A).
