Resolution relative to entering into the 2014 through 2015 Member Library Agreement between the City of Milwaukee, Milwaukee Public Library, and the Milwaukee County Federated Library System.

This resolution authorizes the proper City of Milwaukee (CITY), officers and Milwaukee Public Library (MPL) to enter into the 2014 through 2015 Member Library Agreement with the Milwaukee County Federated Library System (SYSTEM), relative to providing library services in Milwaukee County.

Whereas, The Milwaukee County Federated Library System was established to facilitate the orderly and efficient operation of cooperative library services throughout Milwaukee County; and

Whereas, The City of Milwaukee (CITY), and Milwaukee Public Library (MPL) have previously entered into agreements with the Milwaukee County Federated Library System (SYSTEM) relative to membership in the system; and

Whereas, The MPL has been a member of the SYSTEM since its formation in 1973; and

Whereas, It is beneficial to the CITY and MPL to enter into the 2014 through 2015 Member Library Agreement with the SYSTEM; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that the MPL and the proper CITY officers are

hereby authorized to enter into the 2014 through 2015 Member Library Agreement by the City Attorney's Office.
