Substitute resolution approving levying of assessments and construction of assessable public improvement projects at various locations. -Analysis-

This resolution confirms the report of the Commissioner of Public Works, as modified by the Common Council Committee, on projects for which Public Hearings have been held. The resolution authorizes the levying of special assessments and directs the installation and construction of said public improvements.

Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions, determining it necessary and in the public interest to construct and levy special assessments for the following improvements:

N. Range Line Rd./N. 27th St. - W. Good Hope Rd. to N. Green Bay Ave. (ST30882301) File Number 990932: Concrete pavement construction, place curb and gutter, sidewalk and driveway approaches, and tree removal where necessary. (State or Federal Funds -- \$233,100; Nonassessable State Aid Fund -- \$4,200; Assessable State Aid Fund -- \$57,800; State/Federal Grantor Paving Fund -- \$15,000)

N. Range Line Rd./N. 27th St. - W. Good Hope Rd. to N. Green Bay Ave. (SW30882301) File Number 991463: Install storm sewer. (State or Federal Funds -- \$68,000; Nonassessable New Sewer Fund -- \$500; Assessable New Sewer Fund -- \$16,500)

Whereas, Notices have been sent to all interested persons and public hearings held; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that the Commissioner of Public Works' Report, as amended at said Public Hearing, is approved and the properties therein identified are benefited; and, be it

Further Resolved, That said Commissioner of Public Works is authorized and directed to proceed with said work in accordance with said report pursuant to Section 66.60 and any other pertinent sections of the Wisconsin Statutes and in the manner directed by Section 115-42 of the Milwaukee Code of Ordinances; and, be it

Further Resolved, That the proper departments take such action as is required of them to assess the abutting or adjacent properties and collect such assessment in the manner directed by Section 115-42 of the Milwaukee Code of Ordinances; and, be it

Further Resolved, That the City Comptroller is authorized and directed to transfer such funds which are available for this purpose to the appropriate capital Project/Grant accounts; and, be it

Further Resolved, That the projects do not involve any parcels of agricultural land which are eligible for deferred special assessments under the provisions of Section 14.30 of the Milwaukee City Charter; and, be it

Further Resolved, That the City Engineer is authorized and directed to approve and make periodic payments to the State of Wisconsin, Department of Transportation after receipt of invoices from said State for the City's share of the costs for said projects

Further Resolved, That upon the completion of projects ST30882301 and SW30882301 and a determination of the actual costs, it is understood that if the City of Milwaukee's share is less than the amount previously paid, the difference will be refunded to said City; and, be it
