Whereas, Said vacant, tax-deed lot adjoins Mr. and Ms. Golownia's property and they are the only eligible buyers of this landlocked property; and

Whereas, The Department of City Development recommends acceptance of this Offer to Purchase; and

Whereas, Said lot is being sold in an "as is" condition and the City of Milwaukee makes no representations as to the condition of the lot including, but not limited to soil or
