THE CHAIR

Substitute resolution approving construction of nonassessable public improvements at various locations and appropriating funds for these purposes with the City construction cost estimated to be \$5,738,098 for a total estimated cost of these projects being \$6,043,838.

This resolution directs the installation and construction of certain public improvements which have been determined to be nonassessable by the Commissioner of Public Works. The City cost of the projects approved by this resolution is estimated to be \$5,738,098. The total estimated cost of these projects is \$6,043,838.

Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions determining it necessary and in the public interest to construct nonassessable improvements; and

Whereas, Plans, specifications and cost estimates have been prepared for the following described improvements:

1st, 6th and 7th Aldermanic Districts

Area bounded by W. Nash St., W. Capitol Dr., N. 24th St., and W. Hopkins St. (SM494130201) File Number 121753: Sanitary Sewer lining. (Infiltration/Inflow Reduction Fund -- \$425,000). The total estimated cost for this project including the requested amount is \$445,000. This project is anticipated

to be completed during the 2014 construction season.

#### 5th Aldermanic District

W. Appleton Ave. - 70 feet m/l northwest of W. Derby Pl. to 25 feet m/l northwest of W. Derby Pl. (SM495130077) File Number 130688: Relaying storm sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$74,000). The total estimated cost for this project including the requested amount is \$86,000. This project is anticipated to be completed during the 2014 construction season.

#### 7th Aldermanic District

Further Resolved, That upon the completion of project: N. 45th St. (900N) - Bridge over the Menomonee River and approaches (BR320062201/ST320062201) (2984-39-02) and a determination of the actual costs, it is understood that if the City of Milwaukee's share is less than the amount previously paid, the difference will be refunded to said City; and, be it

Further Resolved, That the Department of Public Works is authorized to use the funding as specified in the above description of work; and, be it

Further Resolved, That the City Comptroller is authorized and directed to transfer such funds which are available for this purpose to the appropriate capital Project/Grant accounts.
