THE CHAIR

Resolution authorizes the City Comptroller to transfer additional funds to the previously established subaccounts for the Wisconsin Department of Transportation and the City of Milwaukee for cost participation and installation of various capital improvements in conjunction with five projects in various Aldermanic Districts with a total estimated cost increase for all five projects of \$250,000, with an estimated grantor share increase of \$79,000.00 and an estimated City share increase of \$171,000.

Resolution authorizes the City Comptroller to transfer additional funds to the previously established subaccounts for the Wisconsin Department of Transportation and the City of Milwaukee for cost participation and installation of various capital improvements in conjunction with five projects in various Aldermanic Districts. This resolution authorizes the

Comptroller to transfer funds to the appropriate subaccounts for the six projects. The total estimated cost increase for all five projects is \$250,000, with an estimated grantor share increase of \$79,000, and an estimated City share increase of \$171,000.

Whereas, Additional planning and coordination and additional construction work at the construction stage have resulted in increased costs charged against five capital improvement projects; and

Whereas, Additional funds are, therefore, necessary to complete the construction of six projects; now, therefore, be it.
