Substitute motion amending the Common Council Procedure and Rules relating to standing committee assignments.

This motion amends the Common Council Procedure and Rules by transferring the assignment of matters relating to alarm businesses and public passenger vehicle licenses and permits from the Public Safety Committee to the Public Works Committee.

In addition, the assignment of matters relating to parking regulations and traffic control will remain under the Public Safety Committee.
