This resolution will approve a final plat that provides 14 blocks for future gravesites. Resolved, By the Common Council of the City of Milwaukee that the final plat of Spring Hill Cemetery Section 5, being part of the Northwest 1/4 of the Northwest 1/4 of Section 35, Township 7 North, Range 21 East, in the City of Milwaukee, Milwaukee County, Wisconsin, bounded and described as follows:

Commencing at the Northwest corner of the Northwest 1/4 of said Section; thence South 01 deg. 25 min. 24 sec. West along the west line of said 1/4 Section 494.19 feet to a point; thence North 88 deg. 32 min. 04 sec. East 1044.62 feet to the point of beginning of the lands to be described; thence continuing North 88 deg. 32 min. 04 sec. East 208 feet to a point; thence South 01 deg. 27 min. 56 sec. East 113 feet to a point; thence North 88 deg. 32 min. 04 sec. East 4 feet to a point; thence South 01 deg. 27 min. 56 sec. East 82 feet to a point; thence South 88 deg. 32 min. 04 sec. West 212 feet to a point; thence North 01 deg. 27 min. 56 sec. West 195 feet to the point of beginning; having been approved by the City Plan Commission and the Commissioner of Public Works, is approved. DCD:JRH:vlk 06/19/01/D
