Stats., for an appeal that was filed as shown in this file, from date of payment to date of repayment; the amount to be charged to the 2014 Remission of Taxes Fund, 0001 Org 9990 Program 0001 Sub-class S163 Account 006300 and the checks to be delivered to the Customer Services Unit of the Treasurer's Office for disbursement; and, be it
