Substitute ordinance relating to the change in zoning from Multi-Family Residence (R/D/40) to Local Business (L/D/40), located on the North Side of West Lisbon Avenue and West of North 50th Street, in the 17th Aldermanic District.

This substitute ordinance will change the zoning to allow for the expansion of an existing retail business.

The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. There is added to the Milwaukee Code of Ordinances a new section to read as follows:

Section 295-320(8).0049. The zoning map is amended to change the zoning for the area bounded by the centerline of North 50th Street, a line 403.8 feet South and parallel to the south line of West Wright Street, a line 140 feet North and parallel to the north line of West Lisbon Avenue, a line 383.75 feet South and parallel to the south line of West Wright Street and a line 120 feet North and parallel to the north line of West Lisbon Avenue, from Multi-Family Residence (R/D/40) to Local Business (L/D/40).
