THE CHAIR

Substitute ordinance to amend the 2002 rates of pay of offices and positions in the City Service under control of the Common Council.

The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 2 of ordinance File Number 010467 relative to rates of pay of offices and positions in the City Service is hereby amended as follows:

Under Salary Grade 003, add the title "Medical Benefits Coordinator."

Under Salary Grade 005, add the title "Compliance Analyst" and add the footnote designation "3/" following the title "Automotive Mechanic Supervisor II" and add the following footnote: "3/ The incumbents of positions in this class, if certified by the Commissioner of Public Works as being, when appropriate, regularly involved in snow and ice control operations which result in an excessive amount of overtime work, to receive 4.8% additional biweekly salary as compensation for such overtime work."

Under Salary Grade 006, add the footnote designation "2/" following the title "Building Services Manager."

Under Salary Grade 007, add the footnote designation "3/" following the title "Vehicle and Equipment Specialist."

Under Salary Grade 008, add the footnote designation "3/" following the titles "Automotive Mechanic Supervisor III" and "Quality Assurance Coordinator" and add the following footnote: "3/ The incumbents of positions in this class, if certified by the Commissioner of Public Works as being, when appropriate, regularly involved in snow and ice control operations which result in an excessive amount of overtime work, to receive 4.8% additional biweekly salary as compensation for such overtime work."

Under Salary Grade 018, add the title "Operations Division Director" and delete the title "Deputy Commissioner - Public Works."

Add the following paragraph at the beginning of Section 2 (Management Employees), above the first salary grade:

"All management salary grade pay steps that exceed \$50,000 (\$1,923.08 or more biweekly) as of Pay Period 26, 2001, will remain at 2001 rates for six months (Pay Periods 1-13 of 2002). Effective Pay Period 14, 2002, the 3.0% wage increase for 2002 will be applied to those pay steps. The effective date for the scheduled step increases for the Mayor and Common Council members will also be delayed 13 pay periods from Pay Period 10 to 23, 2002. Specific information is provided in each affected salary grade."

Delete the current rates of pay for Salary Grades 001-020 and substitute the following rates and effective dates.

The provisions of all other parts of this ordinance are deemed to be in force and effect from and after Pay Period 1, 2002 (December 23, 2001).

Part 13. This ordinance will take effect and be in force from and after Pay Period 1, 2002 (December 23, 2001).
