THE CHAIR

A substitute ordinance relating to the change in zoning from Local Business to Two-Family Residential, for land consolidation, on land located at 210 West Keefe Avenue, on the north side of West Keefe Avenue, west of North 2nd Street, in the 6th Aldermanic District.

Resolved, That the Mayor and Common Council of the City of Milwaukee, do ordain as follows:

Part 1. There is added to the Milwaukee Code of Ordinances a new section to read as follows:

Section 295-501.2(c).0011. The zoning map is amended to change the zoning for 210 West Keefe Avenue, Tax Key No. 273-0324-121, from Local Business (LB2) to Two-Family Residential (RT4).
