Historic Structure. (Historic Preservation Commission)
This resolution designates Bethel Evangelical Church, 2392 South Woodward Street.
Whereas, The Milwaukee Historic Preservation Ordinance, Section 308-81 of the Milwaukee
Code of Ordinances, as amended, provides that Historic Sites, Structures and Districts
may be designated by the Common Council of the City of Milwaukee upon the recommendation
of the Historic Preservation Commission; and

Whereas, The Historic Preservation Commission recommends that Bethel Evangelical Church, 2392 South Woodward Street, be designated as an Historic Structure; and

Whereas, This structure possesses integrity of location, design, setting, materials, workmanship and association and fulfils the following criterion set forth in Section 308-81(2)(e):

- e-4. Its portrayal of the environment of a group of people in an era of history characterized by a distinctive architectural style.
- $\mathrm{e}{-5}$. Its embodiment of distinguishing characteristics of an architectural type or specimen.
- e-6. Its identification as the work of an artist, architect, interior designer, craftsperson, or master builder whose individual works have influenced the development of the City of Milwaukee, State of Wisconsin or the United States.
- e-9. Its unique location as a singular physical characteristic which represents an established and familiar visual feature of a neighborhood, community or the City of Milwaukee.
- ; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee that Bethel Evangelical Church, 2392 South Woodward Street, and further described as follows:

J. Williams Subd in NE 1/4 & NW 1/4 SEC 9-6-22 Block 4 Lot 8 & S 20' Lot 9.

be designated as a Milwaukee Historic Structure. The Preservation Guidelines pursuant to the Historic Designation Study Report, a copy of which is attached to this Common Council File, shall apply to this structure and are adopted by the Common Council as part of this resolution.
