Resolution relative to application, acceptance and funding of the Sexually Transmitted Diseases Grant. (Health Department)

This resolution authorizes the Health Department to apply for, accept and fund the Sexually Transmitted Diseases Grant from the Wisconsin Division of Health and Family Services in the amount of \$126,636. The purpose of the project is to reduce the incidence and complications of sexually transmitted diseases through preventive health education services and focused disease intervention activities.
