Resolution relative to application, acceptance and funding of the Fetal Infant Mortality Review Grant. (Health Department)

This resolution authorizes the Health Department to apply for, accept and fund the Fetal Infant Mortality Review Grant project from the U.S. Health Resources and Services Administration through the Black Health Coalition of Wisconsin in the amount of \$85,000. The purpose of the project is to resume the interdisciplinary review of infant deaths occurring in the City of Milwaukee to identify opportunities to reduce infant mortality and support families at risk.

Whereas, The City of Milwaukee appears to be eligible for grant funds from the U.S. Health Resources and Services Administration through the Black Health Coalition of Wisconsin for the interdisciplinary review of infant deaths occurring in the City of Milwaukee to identify opportunities to reduce infant mortality and support families at risk; and

Whereas, The operation of this grant project from June 1, 2002 to May 31, 2003 would cost \$85,000 entirely provided by the grantor; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that application to the Black Health Coalition of Wisconsin is authorized and the Health Department shall accept this

grant without further approval unless the terms of the grant change as indicated in Common Council File 940843 (Grant Ordinance); and, be it

Further Resolved, That the City Comptroller is authorized to:

1. Commit funds within the Project/Grant Parent Account of the 2002 Special Revenue Grant and Aid Projects, the following amounts for the project titled Fetal Infant Mortality Review Grant:

2. Create the necessary Special Revenue Fund - Grant and Aid Project/Grant and Project level values; budget to these Project/Grant Values the amount required under the grant agreement; and, be it

1. Expend from the amount budgeted sums for specified purposes as indicated in the grant budget and incur costs consistent with the award date;
2. Expend from the 2002 grant budget funds for training and out-of-town travel by departmental staff; and
3. Enter into subcontracts and leases as detailed in the grant budget.
