This resolution authorizes the City Comptroller to transfer additional funds to the construction project grant number in the amount of \$20,000.

Whereas, The Common Council has previously adopted Resolution File Number 981653 on April 1, 1999 to execute an agreement with the Wisconsin Department of Transportation for programming and construction of a bus-only ramp connecting North Harbor Drive to I-794 through a CMAQ grant; and

Whereas, Additional work during the construction stage has resulted in the

need for additional funds for the traffic control portion of costs for the project; now, therefore, be it
