THE CHAIR

Substitute resolution relative to application, acceptance and funding of a Milwaukee County Youth Employment Program (MCYEP) Summer Program Grant. This substitute resolution authorizes the Milwaukee Public Library (MPL) to apply for, accept and fund a MCYEP Summer Program Grant from Milwaukee Employment and Training, Inc. in the amount of \$2,954 with a city share of \$812 and a grantor share of \$2,142. The purpose of the project will allow MPL to improve the system wide use of technology services. Whereas, The City of Milwaukee appears to be eligible for grant funds from Milwaukee Employment and Training, Inc. for the purpose of improving the system wide use of technology resources; and

Whereas, The operation of this grant from 06/10/02 to 08/31/02 would cost

\$2,954 of which \$812 (27%) would be provided by the city and \$2,142 (73%) would be provided by the grantor; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that the Milwaukee Public Library shall accept this grant without further approval unless the terms of the grant change as indicated in Common Council File 940843 (Grant Ordinance); and, be it

Further Resolved, That the City Comptroller is authorized to:

1. Commit funds within the Project/Grant Parent of the 2002 Special Revenue--Grant and Aid Projects, the following amounts for the project titled MCYEP Summer Program Grant:

2. Create the necessary Special Revenue Fund - - Grant and Aid Project/Grant and Project Level values; budget to these Project/Grant values the amount required under the grant agreement;

3. Establish the necessary City Share Project values; and, be it
