This resolution authorizes payment of the settlement amount agreed to in the lawsuit entitled *Jose Aponte v. City of Milwaukee and Pamela Heidemann*, in the amount of \$6,000.00. Whereas, Jose Aponte filed a lawsuit against the City of Milwaukee and Pamela Heidemann, seeking an unspecified amount of damages as a result of his stop and search, which occurred on April 11, 1998; and

Whereas, The parties have agreed to a total settlement amount of \$6,000.00; and

Whereas, The City Attorney recommends and the Common Council of the City of Milwaukee deems it expeditious and just to pay this judgment; now, therefore, be it
