"(S)" as follows: "To expire 9/30/03 unless the Alcohol-related STD/HIV Risk Counseling Grant, available from the Medical College of Wisconsin is extended. .5 FTE of the Nurse Practitioner position is funded by the STD/HIV Prevention Training Grant" and amend footnote "(BB)" as follows: "To expire 4/30/03 unless the STD/HIV Prevention Training Grant, available from the Cincinnati Health Department, is extended. .5 FTE of the position is funded by the Alcohol-related STD/HIV Risk Counseling Grant"; and under "SURVNET Grant (V)", add one position of "Office Assistant III (V)" and delete one position of "Office Assistant II (V)" and amend footnote "(V)" as follows: "To expire 06/30/03 unless the SURVNET Grant is extended."

Part 3. Section 1 of ordinance File Number 010468 relative to offices and positions in the City Service is hereby amended as follows:

Under "Police Department, Administration/Services Decision Unit, Technical Services Bureau, Communications Maintenance Division", delete one position of "Police Electronic Technician," and add one position of "Electronic Technician."

Part 4. All ordinances or parts of ordinances contravening the provisions of this ordinance are hereby repealed.

Part 5. The provisions of this ordinance are deemed to be in force and effect from and after the first day of the first pay period following passage and publication.

Part 6. This ordinance will take effect and be in force from and after its passage and publication.
