W. Waterford Ct. (Extended) (Private Roadway) - S. 60th St. to 600 feet m/l west of S. 60th St. (ST210020102) File Number 991429: Concrete pavement construction, place all curb and gutter,

place sidewalk and driveway approaches where needed, sodding, grading, and tree removal where necessary. (Nonassessable New Paving Fund -- \$230,000)

W. Waterford Ct. (Extended) (Private Roadway) - S. 60th St. to 600 feet m/l west of S. 60th St. (ST240020402) File Number 991429: Install street lighting. (Nonassessable Street Lighting Fund -- \$30,000)

Easement west of S. 60th St. - 180 feet m/l north of W. Waterford Ct. to 680 feet m/l west of S. 60th St. (SW170020111) File Number 991429: Sanitary sewer expansion of capacity. (Nonassessable Expansion of Capacity Sewer Fund -- \$40,000)

Water Easement 885 (Indian Community Center) from S. 60th St. to W. Norwich St. (WT410021059) File Number 991429: Water main extension. (Nonassessable Water Fund -- \$145,000)

Resolved, By the Common Council of the City of Milwaukee that the Commissioner of Public Works is authorized and directed to proceed with said work; and, be it

Further Resolved, That the City Comptroller is authorized and directed to transfer such funds which are available for this purpose to the appropriate capital Project/Grant accounts.
