Further Resolved, That members have reviewed the records relating to the towing incident, and have taken testimony from the claimant and City representatives. Based on this review, members of the Committee have recommended settlement of the claim for \$250.00, which represents reimbursement for the broken signal light along with the dent surrounding the light. This resolution would release the City from any further liability arising from this incident; and, be it
