THE CHAIR

An ordinance relating to mileage reimbursements for certain employees.

350-183-7-a-2 am

Pursuant to the terms of recently-completed labor negotiations, this ordinance increases the base monthly mileage reimbursement received by employees represented by the Staff Nurses' Council from the current \$35 to \$40. This change is effective January 1, 2002.

The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 350-183-7-a-2 of the code is amended to read:

**350-183. Private Transportation Reimbursement.**

7. RATE SCHEDULE.

a-2. Public Health Nurse Mileage Rates. Effective [~~February 1, 1998~~] >> January 1, 2002<<, an employe represented by the Staff Nurses' Council who is required to have a private automobile for use on city business shall receive a base amount of \$~~35~~ >> 40<< per month. The city shall reimburse such employe at the rate of \$.20 per mile for monthly miles driven between one and 200 miles, and \$.31 per mile for monthly miles driven in excess of 200 miles per month.
