Resolution relative to application, acceptance and funding of the Alcohol-related STD/HIV Risk Counseling Grant. (Health Department)

This resolution authorizes the Health Department to apply for, to accept and fund the Alcohol-related STD/HIV Risk Counseling Grant project from the Medical College of Wisconsin in the amount of \$69,131. The purpose of the project will be to compare routine sexually transmitted disease and HIV prevention counseling with an enhanced form of counseling specifically designed for people with alcohol-use disorders.

Whereas, The City of Milwaukee appears to be eligible for grant funds from the Medical College of Wisconsin to the Milwaukee Health Department STD/HIV Clinic to compare routine sexually transmitted disease and HIV prevention counseling with an enhanced form of counseling specifically designed for people with alcohol-use disorders; and

Whereas, The operation of this grant project from 10/01/02 to 09/30/03 would cost \$69,131 provided by the grantor; now, therefore, be it

1. Commit funds within the Project/Grant Parent of the 2002 Special Revenue -Grant and Aid Projects, the following amounts for the project titled Alcohol-related STD/HIV Risk Counseling Grant:

- 2. Create the necessary Grant and Aid Project/Grant and Project/Grant Levels; budget against these Project/Grant values the amount required under the grant agreement;
