THE CHAIR

Resolution determining it necessary to make various assessable public improvements at various locations. (Infrastructure Services Division)

This resolution authorizes engineering studies and directs the Commissioner of Public Works to determine any benefits or damages which would result if the projects were to be constructed. After the Commissioner files his report, a Public Hearing will be held on those projects determined assessable. A resolution will be submitted after the Public Hearing authorizing construction. Resolved, By the Common Council of the City of Milwaukee that it is necessary and in the public interest to do the following described work according to City specifications, and that such public improvements and resulting special assessments be made pursuant to Section 66.60 and any other pertinent sections of the Wisconsin Statutes and in the manner directed by Section 115-42 of the Milwaukee Code of Ordinances:

1st Aldermanic District

N. 26th St. - W. Ruby Ave. to W. Glendale Ave. (ST211040104): Installing concrete curb and gutter. (Nonassessable Reconstruction Paving Fund -- \$4,000)

N. 39th St. - W. Courtland Ave. to W. Hampton Ave. (ST211040105): Paving the roadway with asphalt. Laying a concrete curb and gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work. (Nonassessable Reconstruction Paving Fund -- \$8,000)

3rd Aldermanic District

N. Oakland Ave. - N. Cambridge Ave. to a point north of E. Windsor Pl. (ST211040106): Paving the roadway with concrete. Laying a concrete curb and gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work. (Nonassessable Reconstruction Paving Fund -- \$25,000)

Alley between W. Becher St., W. Grant St., S. Layton Bl., and S. 26th St. (ST212010102): Paving the alley with concrete. Doing all the necessary grading pertaining to said work. (Nonassessable Alley Paving Fund -- \$10,000)

W. Good Hope Rd. - N. 68th St. to N. 76th St. (ST210020103): Installing concrete walk. (Nonassessable New Paving Fund -- \$8,000)

Further Resolved, That all assessments and payments be made in accordance with Section 115-42 of the Milwaukee Code of Ordinances; and, be it

Further Resolved, That all City departments are authorized to do engineering, surveying, preparing of plans, and estimates of cost thereof, to be utilized in the preparation of said report of the Commissioner of Public Works; and, be it

Further Resolved, That the City Comptroller is authorized and directed to transfer such funds which are available for this purpose to the appropriate capital Project/Grant accounts.
