Whereas, The Common Council of the City of Milwaukee approved the award of Large Impact Development (LID) funds to Esperanza Unida, Inc. in the amount of \$100,000; and

Whereas, The timeline for this Large Impact Development project has expired, per the LID policy; and

Whereas, The Community Development Committee has agreed to extend Esperanza Unida, Inc. LID project to January 1, 2003; now therefore, be it

Resolved, That the release of funds will be governed by the LID policy; and, be it

Further Resolved, That the project must submit budget and activity reports according to any conditions approved by the Common Council and the Mayor in conformance with File number 74-92-

Further Resolved That payments for CDBG cost incurred shall be paid in accordance with approved CDBG reimbursement policy based on the approval by the Community Block Grant Administration and City Comptroller of a Budget Forecast (CDA-51).
