Whereas, Intergovernmental collaboration is an appropriate means to accomplish this goal; and

Whereas, Both municipalities have obtained the approval of their governing bodies before entering into an Intergovernmental Cooperation Agreement for the provision of these services; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that the Commissioner of Public Works is authorized to enter into an Intergovernmental Cooperation Agreement with the City of Wauwatosa for the provision by the City of Milwaukee of street sweeping services.
