Resolution dedicating certain City-owned land for public alley purposes to widen the west leg of the east-west alley in the block bounded by West Concordia Avenue, West Keefe Avenue, North 9<sup>th</sup> Street and North 10<sup>th</sup> Street, in the 6th Aldermanic District of the City of Milwaukee.

This resolution will dedicate City-owned land for public alley purposes to widen the west leg of the east-west alley in the block bounded by West Concordia Avenue, West Keefe Avenue, North 9<sup>th</sup> Street and North 10<sup>th</sup> Street

Whereas, The City of Milwaukee has title, by tax foreclosure, to a certain parcel of land located at 3444 North 10th Street; and

Whereas, In 1997 the west leg of the subject alley was improved and widened to a width of 20 feet with a 5-

foot by 5-foot cut off at its intersection with the north-south alley thereby placing the alley pavement on said City-owned land; and

Whereas, The land required to widen the subject alley right-of-way has not been dedicated for such purposes; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee that the following described City-owned land hereby is set aside and dedicated for public alley purposes:

That part of Lot 10 in Block 8 of Milwaukee Savings and Investment Association Subdivision No. 2, a recorded subdivision, in the Southwest ¼ of Section 8, Township 7 North, Range 22 East, described as follows: Commencing at the northwest corner of Lot 10; thence Southerly, along the west line of Lot 10, to a point lying 10.00 feet south of, as measured normal to, the north line of Lot 10; thence Easterly, parallel to said north line, to a point lying 5.00 feet west of, as measured normal to, the east line of Lot 10; thence Southeasterly to a point in said east line, said point lying 15.00 feet south of, as measured normal to, said north line; thence Northerly, along said east line, to the northeast corner of Lot 10; thence Westerly, along said north line, 125.00 feet to the point of commencement; and, be it
