Substitute resolution appropriating \$151,985 from the 2002 Common Council Contingent Fund for the completion of paving work at the Anderson Municipal Building.

This resolution appropriates \$151,985 from the 2002 Common Council Contingent Fund to the Department of Public Works' Lake Tower Renovation Fund for the completion of paving work at the Anderson Municipal Building. The facility is being prepared for occupancy by inspectors from the Department of Neighborhood Services.

Whereas, Certain inspectors from the Department of Neighborhood Services are scheduled to move into new offices at the renovated Anderson Municipal Building on October 24, 2002; and

Whereas, Necessary exterior paving work at the site has not yet been completed; and money to pay for it was not included in the renovation project budget; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that an amount not to exceed \$151,985 shall be transferred from the 2002 Common Council Contingent Fund (0001-9990-0001-C001-006300-2002) to the City of Milwaukee - Department of Public Works' Lake Tower Renovation Fund (BU110020900); and, be it

Further Resolved, That the Comptroller is authorized and directed to establish all funds and necessary accounting procedures to fulfil the intent of this resolution.
