A substitute ordinance relating to the fees and forfeitures for fireworks displays.

200-33-18 rc  
236-31-8 am

This ordinance increases the fee for a fireworks display from the current \$100 to \$150 and increases the range of forfeitures that may be imposed for violating the provisions of the code of ordinances related to fireworks displays from the current \$100-\$500 to \$250-\$1,000.

The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 200-33-18 of the code is repealed and recreated to read:

**200-33. Fees.**

18. FIREWORKS DISPLAY. The fee for each fireworks display permit shall be \$150.

Part 2. Section 236-31-8 of the code is amended to read:

**236-31. Fireworks.**

8. PENALTY. Any person violating this section shall upon conviction forfeit not less than \$~~[[400]]~~ >> 250<< nor more than \$~~[[500]]~~ >> 1,000<<, and upon default thereof shall be imprisoned in the county jail or house of correction for a period not to exceed ~~[[40]]~~ >> 40<< days, or until the forfeiture and costs are paid.
