030413 Substitute 1 020487 THE CHAIR Substitute ordinance to further amend the 2003 offices and positions in the City Service under control of the Common Council. The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 1 of ordinance File Number 020487 relative to offices and positions in the City Service is hereby amended as follows:

Under "Health Department, Consumer Environmental Health Division", delete one position of "Environmental Specialist Coordinator(X)(Y)" and add one position of "Environmental Specialist Coordinator(X)(Y)(E)"; Under "Central", delete seven positions of "Environmental Health Specialist II(X)" and add seven positions of "Environmental Health Specialist II(X)(E)" and add footnote "(E)" as follows: "Positions partially funded by the Innovative Food Safety Grant. To expire 09/30/04 unless funding is extended."

Part 2. Section 1 of ordinance File Number 020487 relative to offices and positions in the City Service is hereby amended as follows:

Under "Police Department" amend footnote "(F)" to read as follows: "A Truancy Abatement

File #: 030413, Version: 1

Grant: Six positions to expire 6/30/04 unless grant funding from the Milwaukee Public Schools continues."

Part 3. All ordinances or parts of ordinances contravening the provisions of this ordinance are hereby repealed.

Part 4. The provisions of all other parts of this ordinance are deemed to be in force and effect from and after the first day of the first pay period following passage and publication.

Part 5. This ordinance will take effect and be in force from and after its passage and publication.
