Substitute ordinance to further amend the 2003 rates of pay of offices and positions in the City Service under control of the Common Council.

The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 14 of ordinance File Number 020486 relative to rates of pay of offices and positions in the City Service is hereby amended as follows (Effective Pay Period 1, 2001 - December 24, 2000):

Under Pay Range 704, eliminate the biweekly rates of pay and substitute in lieu thereof the following biweekly rates of pay:

\$1,220.25 1,247.61 1,276.421,306.72 1,338.65

Under Pay Range 710, eliminate the biweekly rates of pay and substitute in lieu thereof the following biweekly rates of pay:

Part 2. Section 14 of ordinance File Number 020486 relative to rates of pay of offices and positions in the City Service is hereby amended as follows (Effective Pay Period 1, 2002 - December 23, 2001):

Under Pay Range 704, eliminate the biweekly rates of pay and substitute in lieu thereof the following biweekly rates of pay:

\$1,256.86 1,285.04 1,314.71 1,345.921,378.81

Eliminate footnote 1/ and substitute in lieu thereof the following: 1/ Bridge Operators assigned to the maintenance crew on a full-day basis will be paid a premium of \$.50 per hour effective Pay Period 1, 2002 (December 23, 2001).

Under Pay Range 710, eliminate the biweekly rates of pay and substitute in lieu thereof the following biweekly rates of pay:

\$1,323.42 1,351.61 1,381.22 1,412.521,455.13

Eliminate footnote 1/ and substitute in lieu thereof the following: 1/ Bridge Operator Lead Workers assigned to the maintenance crew on a full-day basis will be paid a premium of \$.50 per hour effective Pay Period 1, 2002 (December 23, 2001).

Part 3. All ordinances or parts of ordinances contravening the provisions of this ordinance are hereby repealed.

Part 4. The provisions of Part 1 of this ordinance are deemed to have been in force and effect from and after Pay Period 1, 2001 (December 24, 2000)

The provisions of Part 2 of this ordinance are deemed to have been in force and effect from and after Pay Period 1, 2002 (December 23, 2001)

Part 5. The provisions of this ordinance are deemed to be in force and effect from and after the first day of the first pay period following passage and publication.

Part 6. This ordinance will take effect and be in force from and after its passage and publication.
