Whereas, Members of the Judiciary and Legislation Committee have reviewed the records relating to the reinspections done on the claimant's property, and have taken testimony from the claimant and City

representatives. Based on this review, members of the Committee recommend reimbursing the claimant \$2,400.00, which represents the amount of the re-inspection charges on the 2002 tax bill. However, the City Treasurer has noted that the taxes are delinquent for the property at 2147-49 South 11<sup>th</sup> Street; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that the proper city officers be and they hereby are authorized and directed to issue a city check in the total sum of \$2,400.00, payable to the City Treasurer to be applied toward the unpaid taxes of the property at 2147-49 South 11<sup>th</sup> Street; and, be it

Further Resolved, That the check is to be delivered upon presentation of a proper release, approved by the City Attorney; said amount to be charged to Account No. 636505, Fund - 0001, Organization - 1490, Program - 2631, Sub Class - S118. This resolution would release the City from any further liability arising from this incident.
