This ordinance renumbers 2 aldermanic districts, but does not effect the election wards associated with those districts; the 7<sup>th</sup> district becomes the 10<sup>th</sup>, and the 10<sup>th</sup> district becomes the 7<sup>th</sup>.

The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 301-2-7 and 10 of the code is repealed and recreated to read:

301-2. Aldermanic District Boundaries: 2004.
