This resolution authorizes payment of the judgment in the lawsuit of *Gregory Thornton*, et al. v. Lamont Hodnett, et al., in the amount of \$766,404.92.

Whereas, Gregory Thornton, has filed a lawsuit against the City of Milwaukee seeking an unspecified amount of damages; and

Whereas, The trial court has entered a judgment in this lawsuit against the City of Milwaukee in the amount of \$657,174.20, and, under federal and state law, certain other items, including attorneys fees and interest are due and owing in addition to the judgment amount; and

Whereas, The City Attorney recommends and the Common Council of the City of Milwaukee deems it expeditious and just to pay this lawsuit; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee that the proper City officers be and hereby are authorized and directed to issue a City check in the amount of \$736,452.88 payable to the order of the Trust Account of Schiro & Zarzynski, and \$29,952.04 payable to the Trust Account
